Location of the guest booth or table will be determined by the Market Manager. Guests of the market may distribute information or present demonstrations at the market as described in this application and approved by the Market Manager. No items may be sold by market guests. Those who sell items are considered vendors and must apply as such and pay market fees. Guests are responsible for their own tent/canopy and chairs for the market.

Booth Fees: Seasonal Fee \$150/vendor. \$75 deposit due June 1 and \$75 balance due July 11, or \$10.00 Per Week – payable week-to-week to the Market Manager. Make Checks payable to: Evert Farmer's Market.
Booth Size: min. 12x12 space; additional available if needed

Cancellations should be made no later than 12:30 PM on the Friday prior to Saturday's market by phone or email to the Market Manager.

Applications must be accompanied with first week's booth fee. Acceptance of application does not guarantee a space in the 2015 markets, but will ensure a spot on the market waiting list. Vendors who are not accepted into the Market will be refunded booth fees.
